2025 National Convention Minutes

1. The National Convention of Alpha Chi met April 4 – April 5, 2025, virtually on the Gatherly platform. The National Convention began at 10:00 a.m. Central Time on April 4, 2025, and delegates entered and explored the Gatherly platform's multiple areas, engaging with one another and viewing pre-recorded student presentations available from a YouTube playlist accessible through the platform.
2. At 11:00 a.m., all delegates were directed to the Welcome and Orientation session. Lara Noah, Executive Director, welcomed attendees. Katie Holmes, Director of Operations, provided tips about navigating the Gatherly platform. Attendees were sent on quests to become more familiar with the features of Gatherly. Ms. Noah introduced three student regional representatives, Bre Tonkery Bauman (Region III), Marquesa Calderon (Region VII) and Anthony Sarmiento (Region I), whose terms would expire at the end of this convention. Each representative reflected on their experience in leadership and service on committees, working on the National Council with professors, and how the professors and Alpha Chi office valued their input and working with them. They highly recommended serving as student regional representatives. Noah expressed appreciation for all our student representatives who give a voice to members in their region. Next, she presented the chapter advisors running for vacant at large seats: Dr. Rebekah Crowe of Wayland Baptist University, Dr. Jessica Henry of Hastings College, Dr. Myra Houser of Ouachita Baptist University, Dr. Marshall Johnston of Fresno Pacific University, Dr. Autumn Marshall of Lipscomb University, and Dr. Craig Nakashian of Texas A&M University Texarkana. All delegates had access to candidate descriptions and videos for the last 30 days. Voting opened at the time of this announcement, and Ms. Holmes sent e-mails to all voting delegates containing their ballots. Ballots had to be cast no later than 7:00 p.m. Central on April 4, 2025, and runoff ballots would be provided, if needed, and due by 2:00 a.m. on April 5, 2025. Next, Ms. Holmes provided an overview of the day's events including the collaborative research competition, networking opportunities, chapter development sessions, region meet-ups, and keynote speaker.
3. The first of two Trisha Yarbrough Collaborative Research Competition sessions began at 12:00 p.m. All individuals currently on the Gatherly platform were pulled into the broadcast for this event. Ms. Noah opened the session by thanking the judges for this year's competition: Dr. Jackie Kegley, Dr. Robert Mahan, Dr. Autumn Marshall, and Dr. Steve Hoekstra. Each team submitted a 12-20 page paper, slides, and a presentation, centered on the competition theme, "New Frontiers in Academia and Beyond." The presentations began at 12:05 p.m. with teams from Abilene Christian University (Texas Psi), West Liberty University (West Virginia Epsilon) and Ouachita Baptist University (Arkansas Beta). Each team had 10 minutes to share their project's findings and five minutes to answer questions from the judges.
4. At 1:15 p.m., participants could choose to network with other advisors in the Advisor Networking Lounge, where virtual tables were labeled for new advisors, small chapters, large chapters, or CMS help. Attendees could also view student presentations on the YouTube Playlist or organically engage with others on the platform.
5. At 2:00 p.m., attendees could enter an alumni networking session, or one of four chapter development sessions: The Peer Review Process of *Aletheia* presented by Dr. Tim Lindblom, Jacksonville State University; Building Your Chapter's Brand: Elevate, Integrate, and Engage on Campus presented by Dr. Bre Naegeli, Grand Canyon University; Advisor & Officer Succession Planning presented by Dr. Jessica Henry, Hastings College and Dr. Ruth Nalliah, Huntington University; and Know Your Neighbors presented by Dr. Steve Hoekstra, Kansas Wesleyan University
6. At 3:00 p.m., regions met separately for Regional Meetups. Each meetup, facilitated by the region's leadership team, included introductions, recognizing new or reactivating chapters, and taking nominations for vacant regional leadership positions.
7. At 4:15 p.m., delegates could select among four Chapter Development sessions, including Alpha Chi Journals & Getting Published presented by Dr. Kip Wheeler, Carson-Newman University and Lara Noah, Executive Director; Building Your Chapter's Brand: Elevate, Integrate, and Engage on Campus presented by Dr. Bre Naegeli, Grand Canyon University; Advisor & Officer Succession Planning presented by Dr. Jessica Henry, Hastings College and Dr. Ruth Nalliah, Huntington University; and Know Your Neighbors presented by Dr. Steve Hoekstra, Kansas Wesleyan University.
8. At 5:00 p.m., all delegates were brought into the Collaborative Research Competition, Session B for presentations by Grand Canyon University (Arizona Alpha) and Fresno Pacific University (California Zeta).
9. At 6:00 p.m., all delegates were brought into a broadcast of the Keynote Speaker, Zach Anner, whose memoir is entitled *If at Birth You Don't Succeed: My Adventures with Disaster and Destiny*. Anner described several experiences, including competing for an Oprah Winfrey show, travel accessibility, and his adventures in the Cascades when his friends carried him, inspiring the quote, "Humanity is a team sport." He answered several audience questions and

ended with the inspirational message, "Why would you want to do it alone?"

10. The convention resumed on Saturday, April 5, 2015, at 9:00 a.m. Central Time, when the Gatherly platform opened for independent presentation viewing and socialization.
11. At 10:15 a.m., all individuals on the platform were brought into a Saturday welcome and overview, starting with Jaycie Birdwell, Chapter Support Specialist & Social Media Lead, who thanked all voting delegates. Katie Holmes, Director of Operations, recapped Friday's events. Executive Director Lara Noah provided information about upcoming Saturday events, including Individual Presenter Q&A, inaugural Graduate School Fair, Regional and National Business Meetings, and the Gala and Awards Ceremony. She reminded delegates that students have opportunities to get involved and provide feedback through their regions.
12. Delegates met by region for their Regional Business Meetings at 11:00 a.m.
13. President Linda Cowan called the Alpha Chi National Business meeting to order on Saturday, April 5, 2025, at 12:05 p.m. on the Gatherly platform.
 - a. President's Report: Dr. Cowan addressed the delegates, providing an update on National Council work. The strategic plan, which was developed in 2023, is currently in its first year of implementation. Alpha Chi chartered four new chapters, saw increasing enrollment, and revitalized a dozen dormant chapters. The National Office broadcasted two inductions and launched a national fundraising initiative. The national office seeks feedback from the post-convention evaluation to guide future events. Dr. Cowan thanked the National Office staff and recognized their tireless work.
 - b. Secretary's Report: Dr. Teddi Deka reported that the Audit and Finance Committee presented the annual budget to the National Council in February 2025, which was unanimously approved, and that the Audit & Finance Committee will review the Audit Report soon after the convention.
 - c. At-Large Election Results: Director Noah announced the election results of the At-Large National Council Member election. The following four advisors were elected to serve a four-year term on Alpha Chi's National Council: Dr. Jessica Henry of Hastings College, Dr. Myra Houser of Ouachita Baptist University, Dr. Marshall Johnston of Fresno Pacific University, and Dr. Craig Nakashian of Texas A&M University-Texarkana.
 - d. Regional Election Results: The results of the Regional Officer elections were announced as follows:
 - i. Region I Student Representative 2025-2027: Michaela Zimmerman of Angelo State University.

 - e. Recognitions: Noah recognized the following National Council Members:

Dr. Cowan adjourned the National Business Meeting at 12:30 p.m.

14. At 1:00 p.m., delegates could choose between four Member Development sessions: Applying to Graduate School by the Princeton Review, Interview Tips & Tricks by Texas A&M University-Texarkana chapter, Power Skills by the Lindenwood University chapter, or Resume Writing by the Texas State University chapter.
15. Next, question and answer sessions provided opportunities for delegates to interact with conference presenters,

whose presentations had been available through a YouTube channel on the Gatherly platform. Question and Answer Session A from 2:00 p.m. to 2:25 p.m. included discussion tables for Biology & Health Sciences moderated by Breanna Bauman, Business Management & Mathematics moderated by Katie Holmes, Political Science & Economics moderated by Nolan Reynolds, Education moderated by Dr. Bonita Cade, and Psychology moderated by Azsha Ray. Question and Answer Session B followed from 2:30 p.m. to 2:55 p.m., with discussion tables for Anthropology & Sociology moderated by Dr. Teddi Deka, Fine Arts moderated by Dr. Linda Cowan, Creative Writing moderated by Marquesa Calderon, Literature moderated by Dr. Kate Stewart, and World History moderated by Katie Holmes.

16. The inaugural Graduate School Fair began at 3:00 p.m. Delegates visited tables from the following participating universities: American University School of Public Affairs, Bard College Master of Arts Global Studies, Bowling Green State University Graduate Admissions, Suffolk University, and the University of Louisville School of Public Health & Information Services.
17. The 2025 Convention Awards Gala began at 6:00 p.m. After a warm welcome from Executive Director Noah, President Cowan announced the student presenters chosen to receive \$100 Convention Presentation Prizes endowed to honor those with strong ties to Alpha Chi. The Ellen Millsaps Prize in American Literature went to Destiny Forrest from the University of Arkansas at Monticello for “‘Beyond’ a Kiss: False Salvation in the Realistic American Novel.” The Avery Grenfell Church Prize in Anthropology & Sociology went to Samantha Stokes from William Carey University for presenting “At Different Times.” The Gayle Webb White Prize in Business Management went to Hannah Todd from Mars Hill University for presenting “RSM Profession Challenge: Volunteerism Solutions.” The Thelma Hall Prize in Creative Writing went to Emily Kledzik from Carson-Newman University for a poetry collection entitled “Allure of Appalachia.” The Ann Kneavel Prize in Economics went to Leslie Osborne from Carson-Newman University for “S&P 500 Market Efficiency: A Measure of the Relationship Between the S&P 500 and Presidential Election Outcomes.” The Patricia A. Williams Prize in Education went to Madeline Ross from Fresno Pacific University for “Beyond the Right Answer: Cultivating Creativity in Math Education.” The Blake and Trish Janutolo Prize in Organismal and Ecological Biology went to Olivia Robbins from Huntington University for “A Brief Review of the Role of Plumage Color in Bird Mating.” The Mary Waterstreet Prize in Psychology went to Saskia Fuchs from Lindenwood University for “Trapped in Contradiction: Cognitive Dissonance and the Psychology of Climate Inaction.” The Patricia Graham Prize in World History went to James Seip from Gardner-Webb University for “Encouraging the Empire: How British Propaganda Posters of 1940-43 Attempted to Encourage the Home Front.” The Suzanne and J. T. Pundt Prize for the top presentation by a Graduate Student went to Nisa Sindhi from Texas State University for “PAX6 and Actin Filament Co-Localization in Hair Cells of Neuromasts of Lateral Line System in Eurycea Salamanders.” The Dennis M. Organ Prize for the top presentation by an Alumni Member went to Laura Hand from Fresno Pacific University for original fiction titled, “I am Io.”

Dr. Cowan announced the winners of the Dr. Trisha Yarbrough Collaborative Research Team Competition. Placing first in the competition and winning the \$5,000 prize was Abilene Christian University, Texas Psi for the project entitled, “Marketing and New Member Engagement in the Health and Wellness Industry.” Placing second in the competition and winning a \$2500 prize was Fresno Pacific University, California Zeta for the project entitled, “Literature as Medicine: Bibliotherapy’s Effects on Burnout in Undergraduate Students of a Liberal Arts College.” Dr. Cowan congratulated the winning teams and noted that next year’s competition theme would be announced by August 1, 2025.

The convention ended with a preview of the upcoming 2026 convention, which will take place March 12 to March 14 at the Hilton Orlando Lake Buena Vista. Director Noah closed the convention by thanking the students, advisors, keynote speaker, graduate fair representatives, Gatherly employees, and the Alpha Chi office staff.

President Cowan called the meeting to order at 5:16 p.m. ET.

Dr. Cade moved to approve the March 25, 2025, minutes. The minutes were approved with no corrections.

Other business:

- Introductions (for new Council members): Dr. Cowan asked the following new Council members to introduce themselves: Marshall Johnson, Craig Nakashian, Michaela Zimmerman, Laura Hand, and Tiffany Sites. All attending National Council members introduced themselves to the new National Council members.
- Recognition of Outgoing Council Members: Lara Noah recognized Jodi Pilgrim and student representatives Bre (Tonkery) Bauman and Anthony Sarmiento, who were in attendance, as well as Marquesa Calderon and Lindsey Morais.
- Installation of Incoming Council Members: Dr. Cade inducted newly elected National Council members: Dr. Marshall Johnston of Fresno Pacific University, Dr. Craig Nakashian of Texas A&M University-Texarkana, Michaela Zimmerman of Angelo State University, Tiffany Sites of West Liberty University, and Laura Hand of Fresno Pacific University. Lia Whitman of Mars Hill University could not attend.
- Convention Observations: Lara Noah included a Post-Convention Evaluation Report compiled by Katie Holmes.

New Business:

- Feedback from Regional Meetings: Lara Noah asked for feedback from the regions that may not have been reported in their regional minutes. Dr. Wheeler asked Council members to provide ideas for connecting with neighboring chapters.
- Year-End Committee Reports: The reports submitted were accessible from a shared folder for Council view.
- Auditor's Report and 2024 Financials: Dr. Deka, Audit and Finance Committee Chair, reported that the Committee met on 4/24/25 to review the Auditor's Report and 2024 Financials. The audit provided no recommendations for altering processes.

2025 Executive Committee Meeting Minutes

July 31, 2025, The Westin Birmingham, AL

Present: President Linda Cowan, Vice President Bonita Cade, Secretary Teddi Deka, Executive Director Lara Noah, Director of Operations Katie Holmes.

Absent: None

Dr. Cowan called the Executive Committee meeting on July 31, 2025, to order at 8:47 a.m. Central.

1. **Reviews:** The EC reviewed the recent NC Minutes for action items and determined that all action items were addressed. The EC reviewed the *Proceedings Recorder* draft that contained monthly NC minutes.
2. **Constitution and Bylaws officer role descriptions:** Dr. Cowan recommended reviewing role descriptions, including regional officer descriptions. Ms. Noah added that descriptions may change with any restructuring of the council and/or regions, and that next year's budget includes some money for a parliamentarian in case we need advice.
3. **Committee Tasks:** Dr. Cowan inquired whether assigning small tasks to specific individuals within a committee or to the chair for completion would facilitate task completion. Tasks and dates for accomplishment could appear in the NC minutes and/or on the NC Google Drive, allowing the Executive Committee and National Office to assist and prompt continuation with changes in committee composition.
4. **Working groups for the week's National Council retreat:** The EC reviewed the individuals assigned to each working group and the goals. All members will practice the Mutual Impact Review. Some discussion about regions, regional grants, and elections ensued. Dr. Cowan suggested a separate area in the Strategic Plan concentrating on regions, regional representation, regional programming, and student representation/involvement.
5. **Regional Engagement:** Discussion ensued regarding regional engagement and possible changes to Alpha Chi's regional structure that might be needed. Ms. Noah reminded the Council that any changes to regional structure would have implications for the makeup of the National Council membership. Several proposals for regional realignment were discussed with pros and cons of each discussed. It was decided that those matters would involve changes to the Constitution & Bylaws and would be discussed in the appropriate working group, with probable referral to Strategic Planning. **Invitations:** Currently, Alpha Chi invites the top 10% of students, and the EC discussed inviting the top 15%, who may be hungrier for leadership experiences. A motion would need to go to the National Council.
6. **Separating the national treasurer and secretary responsibilities:** Dr. Cowan presented the possibility of electing a Council treasurer with representation on the EC and National Council, and delegating secretarial duties to an EC member or a council member for the year. The treasurer would assume the responsibility of taking the minutes of the business meeting at the convention and Executive Committee minutes. The position of "secretary" would not continue as a separate position with representation on the National Council. Instead, the position of "treasurer" would be established, with secretarial responsibilities for monthly minutes assigned to another EC member or NC member for the year.
7. **Committee Members and Chairs:** Individuals serving on committees chaired by board member could be from the advisors and not solely from the board.
8. The meeting was recessed at 12:30 p.m. for lunch and reconvened at 2:25 p.m.
9. **Strategic Plan Discussion:** Dr. Cowan examined the five Strategic Plan goals and suggested merging goals two and three and adding another goal, which would be reimagining the regional structure. Any place in the strategic plan that mentions the regional structure would be moved to this goal. Ms. Noah stated that the working group at this council retreat will be reviewing the goals to be added and removed (achieved). Some goals will be maintenance goals, while others will need to be reimagined, or new goals will be added.

10. Implications of a Biennial National Convention: Ms. Noah suggested that we might not need to have an NC meeting that substitutes for the in-person NC meeting during convention years. The EC concluded that the more frequent virtual NC meetings and listening sessions would suffice at least for 2027.
11. National Council Reimbursements: Ms. Noah suggested that we need to have this discussion at some point if we do not reduce the number of individuals on the NC. The proposed idea is that if the NC member is not taking a student delegate, they would receive the National Advisor travel grant and possibly a stipend (such as \$200). An NC member would only receive full travel reimbursement if bringing at least one voting student delegate. [This matter was taken up by Audit & Finance after the retreat.]
12. Reminder: We have a credit for one 8-hr event on Gatherly—this time has already been paid for.

Minutes—April 5, 2025

1. **Call to Order.** President Laura Steil called the meeting to order at 11:00 a.m. Central.
2. **Roll Call.** There were 17 delegates present at the meeting. The chapters represented were Carson-Newman University, Gardner-Webb University, Lander University, Lipscomb University, Mars Hill University, Milligan University, University of North Carolina at Pembroke, and William Carey University.
3. **Regional Election Results.** Dr. Steil announced Lia Whitman as the new Region III Student Representative. A brief installation ceremony was held where Lia Whitman took her oath of office.
4. **Star and Notable Chapters.** Dr. Steil recognized Carson-Newman University, Gardner-Webb University, and Mars Hill University as Star Chapters. Belmont University, Lipscomb University, and Shorter University were all recognized as Notable Chapters.
5. **President’s Cup.** We always have wanted at least one Region III chapter to compete for the President’s Cup. Savannah Stanish advocated that Mars Hill University should compete the next time it’s offered. Kip Wheeler offered to send to Dr. Steil a copy of the application Carson-Newman submitted the last time it competed for the President’s Cup.

- f. 1. **Call to Order.** The meeting was called to order at 3:02 p.m. Central.

Gatherly Navigation Guide for Attendees

Prepare to have a unique convention experience! Gatherly will be a new platform for most of you, and this guide will help you make the most of the convention.

If you need help during the event, don't worry. Gatherly tech support will be available throughout the event, and of course we'll have our usual AX Central table where you can ask Alpha Chi-specific questions.

Understanding the Gatherly Space

Gatherly is designed like a multi-floor venue, allowing you to move freely just like at an in-person event! Here's how to get started:

1. On the top-right corner, you'll find the map. Click anywhere on it to move.
2. To switch floors, click the green Elevator button on the right-hand panel and choose your destination.
3. To join or start a conversation, click on someone's avatar to "tap them on the shoulder." This will allow you to form a huddle and chat in real time.

Above Your Video

You'll see two buttons:

1. **Member Presentations** – Clicking this will open a new tab where you can watch member presentations. Gatherly will remain open in the other tab.
2. **Program of Events** – Clicking this will display a lightbox on your screen, showing the program of events that will help you navigate through the convention.

Broadcast Mode

Broadcast mode is just like a webinar, meaning everyone in the event space can hear the speaker. During a broadcast the speakers cannot see or hear individual attendees. But don't worry—you can still engage via the audience chat, located just below the green Elevator button.

Once the broadcast ends, you'll return to the map where you'll be able to interact with others again. You can choose when and who you'd like to engage with!

Map Mode

Map mode is what makes Gatherly unique! Rather than being stuck in a sea of videos, in map mode you become an avatar on the map at the top right corner of your screen, and you're able to navigate around the various floors of the convention space. Just as an in-person convention takes place in a variety of *rooms*, events on Gatherly take place on different *floors*. Each floor is different, so get ready to explore the unique space we've created for you.

Moving Around & Interacting in Map Mode

1. Click anywhere on the map to move your avatar.
2. Click on someone's avatar to join their conversation and network in small groups. Groups are automatically formed and stacked, allowing for face-to-face conversations.
3. To leave a conversation, simply click another space on the map.

Using Tables and Booths in Map Mode

1. Click on a booth or table to join a structured discussion.
2. Some booths may feature company representatives or resources for you to explore.
3. If a booth has a representative, their name and organization will be displayed when you hover over it.

Chat & Networking Features

Below the Elevator button, you'll find the chat options:

1. Event Chat – Messages everyone in the event.
2. Huddle Chat – Messages only those in your current group.

If you need assistance, look for the Gatherly Help Desk located on Floor 1.

Additional Tools

1. Camera & Mic Controls – Turn your camera and microphone on or off using the toolbar below your video.
2. Live Closed Captioning & Screen Sharing – These tools are also available in the toolbar.
3. Private Conversations – Use the lock button to make your chat private. Unlock it when you'd like others to join.
